The vehicle advertised by the Town of Mt. Crested Butte (the "Town") for sale by bid is sold AS-IS. The Town shall strive to make its best effort to assist interested parties in obtaining information about the vehicle for sale; however, the Town makes NO warranty of the condition of the vehicle nor accuracy of the vehicle description. Each bidder shall be responsible for verifying condition and accuracy of the item description prior to submitting a bid.

The vehicle comes with a Monroe Spreader run by own auxiliary gasoline powered motor and an 11 foot Monroe Plow Blade. The truck is currently exhibiting a loss of power and backfires when or after going downhill.

**Terms of Sale:**

The successful bidder shall be provided a written "Notice of Award" within ten (10) days after bid closing date. Successful bidder shall make full payment with cash or a cashier's check made payable to the Town, and shall arrange to pick up the vehicle within ten (10) days of the Notice of Award.
