TOWN OF MT. CRESTED BUTTE RESOLUTION NO. 19 SERIES 2023

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, CALLING A SPECIAL MAIL BALLOT ELECTION ON THE RECALL OF ROMAN KOLODZIEJ FROM THE OFFICE OF TOWN COUNCILMEMBER, FIXING THE BALLOT TITLE FOR THE SAME, AND AUTHORIZING THE APPOINTMENT OF ELECTION JUDGES

WHEREAS, in accordance with C.R.S. § 31-4-503(4) and Colorado Constitution Article XXI, on November 21, 2023, the Mt. Crested Butte Town Clerk presented the Mt. Crested Butte Town Council ("Council") with a Certificate of Sufficiency concerning a recall petition proposing the recall of Roman Kolodziej from the office of Town Councilmember; and

WHEREAS, pursuant to C.R.S. § 31-4-503(4), the Council is now required to order and fix a date for the recall election to be held, not less than thirty (30) nor more than ninety (90) days from the date of submission of the Certificate of Sufficiency; and

WHEREAS, the Council further finds and determines that it is desirable to authorize the Town Clerk to appoint not less than three (3) election judges, as authorized by Part 4, Article 10, Title 31, C.R.S.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, THAT:

Section 1. The above and foregoing recitals are hereby adopted as specific findings of the Council by reference.

Section 2. The Council hereby fixes and orders the following date for the conduct of a special election on the proposed recall of Roman Kolodziej from the office of Town Councilmember: February 13, 2024.

Section 3. The recall election ordered by this Resolution shall be conducted by mail ballot in accordance with C.R.S. §§ 31-4-503(4), 31-10-907 through 913.

Section 4. The following ballot question shall be submitted to the registered electors of the Town at the February 13, 2024 election:

Section 5. The Town Clerk is authorized to appoint not less than three (3) election judges for the special recall election called hereby, in accordance with C.R.S. §§ 31-10-401, 402.

Section 6. The Council authorizes and further directs the Town Clerk, in consultation with the Town Manager, to take such actions as necessary to prepare for and conduct the special election called hereby.

Section 7. This Resolution shall be effective immediately upon adoption.
