A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, REPEALING AND TERMINATING THE TOWN OF MT. CRESTED BUTTE POLICE PENSION FUND AND DISSOLVING THE PENSION BOARD

WHEREAS, the Town of Mt. Crested Butte (“Town”) is a Colorado home-rule municipality;

WHEREAS, the Town has previously established and funded an Old Hire Police Pension Fund, as currently provided for in Article 30.5, Title 31, C.R.S. (“Fund”);

WHEREAS, the general supervision, management, and control of the Fund is vested in its board of trustees (“Pension Board”), as set forth in Section 31-30.5-203, C.R.S.;

WHEREAS, the Town Council desires to terminate the Fund pursuant to Section 31-30.5-209, C.R.S., effective immediately;

WHEREAS, at least 60 days prior to consideration of this Resolution the Town published notice and provided a copy of such notice to the Board of Directors of the Fire and Police Pension Association consistent with the requirements of Section 31-30.5-209, (3)(a), C.R.S., a copy of such notice, certificate of mailing, and proof of publication are attached hereto and incorporated herein as Exhibit A; and

WHEREAS, Section 31-30.5-209, (2), C.R.S. provides that upon proper notice and a determination that no person is, and no person can become, eligible for payment of a benefit from the Fund, the Town may use the remaining money in the fund to make contributions to the current Town’s current police pension system, and to the extent that money in the Fund exceeds three times the present yearly employer contribution to the Town’s police pension system on behalf of its current police officers, such excess may be used for any law-enforcement-related purpose; and

WHEREAS, no persons who believe they are or may be entitled to benefit payments from the Fund have filed a written objection pursuant to Section 31-30.5-209, (3)(a), C.R.S., to terminating the Fund and using the remaining money in the Fund as authorized by Section 31-30.5-209, (2), C.R.S.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE that:

1. **Incorporation of Recitals.** The above recitals are incorporated herein, in full.

2. **Findings.** The Town Council finds and determines that there are no persons who are, and no persons who can become, eligible for payment of a benefit from the Fund.

3. **Termination of the Fund.** The Town Council hereby terminates the Fund and any associated trust.

4. **Use of Remaining Fund Money.** Any money or other assets remaining in the Fund shall be liquidated and used to make contributions to the current Town's current police pension system, and to the extent that money in the Fund exceeds three times the present yearly employer contribution to the Town's police pension system on behalf of its current police officers, such excess may be used for any law-enforcement-related purpose.

5. **Administrative Matters.** Town staff is authorized and directed to execute such documents and instruments, and to take such other actions as are necessary or advisable to implement the provisions of this Resolution.

6. **Dissolution of Pension Board.** Further, it appearing that there is no further business to come before the Pension Board, said Pension Board is hereby dissolved effective as of the adoption of this Resolution.

7. **Severability.** If any part, section, subsection, sentence, clause or phrase of this Resolution is for any reason held to be invalid, such invalidity shall not affect the validity of the remaining provisions.

8. **Effective Date.** This Resolution shall take effect and be enforced immediately upon its approval by the Town Council.

I spoke with Mike Sutherland at the FPPA and he agrees with my interpretation that while notice is required to be given to FPPA, it does not have to be received 60 days prior to the Town Council adopting the resolution. So, Council is good to proceed next week with the Resolution.

If no one shows up to make a claim or objection or files one before the meeting, the path will be clear to terminate the plan. You will need to send a copy of the signed Resolution, the notice, and proofs of publication to Ahni Smith at the FPPA. I recommend you call Ahni first and go over what she will need from you. Her telephone number is 303-770-3772. You will have to navigate their directory to get to her extension. Mike is letting Ahni know of the Town's termination of the fund and to expect your call. Please send me copies of any correspondence so I can have a complete file.

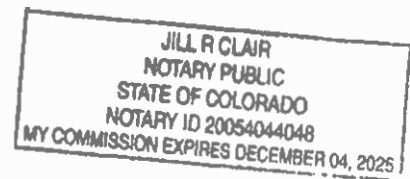


