A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, ESTABLISHING AN ELECTRONIC BICYCLE REBATE PROGRAM FOR APPROVED TOWN RESIDENTS FOR 2024

WHEREAS, the Town of Mt. Crested Butte is a home-rule municipality operating under a charter approved by its electors and governed by its Town Council (the "Council"); and

WHEREAS, the Council recognizes that incentivizing e-bike use contributes to the environmental benefits of reducing carbon emissions and promotes a more sustainable community; and

WHEREAS, pursuant to this authority and via Resolutions No. 9, No. 10, and No. 11, Series 2023, the Council previously adopted and revised the Mt. Crested Butte E-Bike Rebate Program (the "Program") to be administrated by Town Staff, with an associated initial funding allocation; and

WHEREAS, pursuant to this authority, the Council desires to renew its adoption and approval of the Program to be administrated by Town Staff for the 2024 calendar year, with an associated initial funding allocation.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MT. CRESTED BUTTE, COLORADO, THAT:

Section 1. E-Bike Program Approval. The Town Council hereby approves the *Mt. Crested Butte E-Bike Rebate Program* attached hereto as **Exhibit A**. The Town Council permits Staff to make such Program modifications deemed necessary within budget.

Section 2. Funding. The Town Council approves a dedicated sum of \$10,000 to fund the Program and directs that this amount be included in a supplemental budget appropriation when appropriate.

Section 3. Program Review. The Town Council shall commence a review of the Program in the first quarter of 2025 year to evaluate the program's effectiveness, and to consider the implementation of the Program going forward.

Section 4. Effective Date. This Resolution shall be effective immediately upon adoption.

Exhibit A To Resolution No. X Series 2024

Mt. Crested Butte E-Bike Rebate Program

The Mt Crested Butte E-bike Rebate Program is a sustainability initiative that aims to promote the use of e-bikes as a means of transportation. The program offers a rebate to Mt Crested Butte residents who purchase an e-bike with the goal of reducing traffic congestion and promoting environmentally friendly transportation options. By incentivizing e-bike use, the program seeks to contribute to the environmental benefits of reducing carbon emissions and promoting a more sustainable community.

Rebate Amount:

\$500 to \$600 per e-bike. Rebate amount depends on where the e-bike was purchased. One rebate per person.

If the e-bike is purchased from a Gunnison County retailer applicant will earn an additional \$50 rebate, for a total of \$550.

If the e-bike is purchased from a Mt. Crested Butte retailer you will earn another \$50 rebate for a total of \$600.

Rebate cannot exceed the cost of the e-bike.

Maximum Retail Price for e-bike:

\$5,000

Requirements:

Receipt of the e-bike purchased after May 7, 2025.

Must request the rebate within 90 days of the date of purchase.

Must submit a picture of the sticker on the e-bike showing the class, maximum watts and maximum speed of the e-bike. If the sticker is not present on your e-bike you will not receive a rebate.

Full suspension bikes are not allowed.

Mt. Crested Butte Residence Requirements

This rebate program is for Mt. Crested Butte Residents. You must provide one of the following:

- Colorado Driver's License with a Mt. Crested Butte address.
- Mt. Crested Butte voter registration.
- Current lease for a Mt. Crested Butte residence.



Own real residential property in Mt. Crested Butte.

If the person applying is under 18 and cannot provide one of the following the person must apply in person with their parent or guardian who can provide one of the above.

Town of Mt. Crested Butte employees are eligible for this rebate.

Qualifying E-Bikes:

New e-bike, Class 1, 2 or 3. E-bike must be new to qualify for rebate; no used, reconditioned, or aftermarket bikes are eligible. Only e-bikes which meet the definition of a Class 1, 2, or 3 "electrical assisted bicycle" as defined at C.R.S. § 42-1-102 are eligible. An e-bike which does not have affixed to its frame the manufacturer's label required by C.R.S. § 42-4-221 is not rebate eligible. An applicant must provide evidence of a purchased e-bike's rebate eligibility.

Town Staff Discretionary Authority

The Town Council expressly grants Town Staff discretionary authority in the application of the program's criteria when reviewing submitted rebate requests.

Current Budget for the Program \$10,000*
